### NARRATIVE

1. On 8/9/2010 at approximately 0715 hours, I, Officer Murawski-Dupont had arrived to Dudley MBTA station to begin my day shift 0730-1530 hours. I exited my personal vehicle and was confronted by a black male, later identified as Henry Lee Alexander. He yelled in a threatening manner, "I am going to fuck you up and kick the shit out of you." also stepping towards me. I recognized Alexander from a previous incident a week prior, where I trespassed him from the station and when I did he threatened with bodily harm.

2. On todays date, after being threatened by Alexander I demanded that he leave the station also issuing him a verbal trespass warning. Alexander walked away from me but was still yelling and swearing while doing so. I then exited the area, in order to dress in my full police uniform.

3. A couple of minutes later I returned to the area. Alexander immediately charged at me. Alexander stood directly in front of me and went into a fighting stance, swinging at me with clenched fists. I requested additional units and removed my department issued O.C. spray. Alexander then with a silver cane, charged at me swinging it at me. I avoided being hit by the cane several times. Alexander then cocked back his cane, charged at me



I pursued Alexander out of the station and onto Malcolm X Blvd. Alexander continued to violently swing his cane at me. Each time he swung he charge me and each time I was able to nearly able to avoid be hit.

4. A unidentified Boston police officer, arrived and we were able to tackle him to the ground. After I brief struggle, I was to place Alexander in handcuffs, placing him in custody.

5. Alexander was transported to Transit police headquarters in to booked and processed. Alexander was charged with Assault and Battery Dangerous Weapon, Assault an Battery Police Officer, Disorderly Conduct, Threats and Resisting Arrest.
