1. On 05/17/2010 at approximately 00:50 hrs., I, Officers Smith (772) and Bartlett (772) along with Sergeant Keith, responded to Beacon and Kent Streets for a report of an

**NARRATIVE**

affray in progress on trolley 3846. Upon my arrival, I observed numerous Brookline Police units conducting an area sweep for the suspect who fled prior to my arrival. This incident had been upgraded to an unarmed robbery.

2. At this time, I had a brief conversation with the victim, [REDACTED] stated, 15 minutes prior, he boarded the C Line trolley (#3846) while at Arlington Station. [REDACTED] stated, during the trolley ride from Arlington Station to Kent Street, he was approached by an unknown male party and immediately assaulted without provocation.

3. [REDACTED] stated, this unknown subject approached him, grabbed his legs and tossed him in an upward motion by pulling and lifting his legs. [REDACTED] said, the suspect then began to strike him while saying, "Give me your shit, [REDACTED]." [REDACTED] stated, during the assault the suspect grabbed his cell phone, IPod and wallet.

4. [REDACTED] stated, he resisted being robbed by the suspect and a violent struggle ensued. During the struggle, [REDACTED] suffered a bruise under his left eye. All three items were later recovered by the victim after he fought back in self defense.

5. According to the victim, once the trolley stopped at the intersection of Beacon and Kent Streets, the unidentified suspect ran off in the direction of St. Paul Street. An extensive area sweep was conducted by all responding units including the Brookline Police Department and the Massachusetts State Police. After approximately 35 minutes, I received a call from Officer Bartlett (771). Officer Bartlett advised me that they had a possible suspect detained near the 1200 Hotel.

6. I responded to the area with the victim, [REDACTED]. He was given a standard show-up admonishment by Officer Weinstein of the Brookline Police Department. A show-up was conducted as [REDACTED] was seated in my cruiser. As I drove by the suspect was seated approximately 25 feet away. The victim had a clear and unobstructed view of the suspect who was not in handcuffs. As soon as the victim saw the suspect, he said, "That's him." The suspect, later identified as Jessie Gove, was taken into custody and transported to Transit Police headquarters for booking in the usual manner.

7. In addition to the Transit Police units, units from the Brookline Police Department were identified as 265, 109, 260, 103, 239, 259 and 016, Sgt Gruber. Massachusetts State Police Sgt. Halfkenny (933) also assisted. The victim was taken home after the initial investigation. The listed witnesses corroborated the victims story and will be available for court.
